• Expressed hope that everyone had a good holiday season. She enjoyed attending Christmas in the Village and the Parade with her family.

Treasurer's Report:

- Disbursement amounts through December 2013 were listed for the record.
- Partial summer and winter 2013 taxes can still be paid until March 1, 2014. Interest is due on the unpaid balance only. Credit card payments can be made from the convenience of your home. Directions are on the back of your tax bill.

Clerk's Report:

- Extended appreciation to the Edna Burton Senior Center Auxiliary Board, the Ortonville Lions Club, and all the volunteers and individuals during the recent storm and power outages to ensure the generator at the senior center was in full operation. The EBSC served as a warming station providing eleven citizens overnight refuge.
- Annette Beach was commended for going "above and beyond" in comfort and services; including offering meals at her own expense. Procedures will be established to publicize the emergency services and shelter available as well as provide for food and other items needed at such times.

Supervisor's Report:

- 314 natural gas applications for the natural gas main extension project have been received,
 427 is the goal. Consumers Energy will release some of the roads with 50% participation and will compile it to be published in the local paper next week.
- Radon is the 2nd leading cause of lung cancer. Oakland County is providing radon test kits for \$5.00 during the month of January. They can be purchased from Bldg. 34 E at the Oakland County complex. The phone number to contact them with any questions is 248-858-1312.
- It has been a rough winter with 138,000 customers affected by power outages; 5,000 of those were in Brandon Township. Household precautions should include assembling an emergency kit by keeping a cell phone fully charged and handy and include clean drinking water and additional blankets.
- The Oakland County Road Commission cautioned that it is illegal to plow snow and ice into the public roadways.
- The Community Emergency Response Team (CERT) did respond during the recent storms. If
 there are elderly or disabled individuals needing help, please contact the Fire Department to
 be placed on the list for CERT to check on your welfare during emergency situations. Clerk
 Allen added that the senior center can also be contacted for the same purpose and they will
 forward the information to CERT.

UNFINISHED BUSINESS:

A. Building Department: 2nd reading of an Amendment to the Code of Ordinances, Chapter 28, Article V. Offenses Against Public Peace, Use of Consumer Fireworks adding section 28-230 Use of Consumer Fireworks as follows:

"Section 28-230. Use of Consumer Fireworks

It shall be unlawful for any person to ignite, discharge or use consumer fireworks except:

- a) On the day preceding, the day of, or the day after a national holiday as defined in 5 USC 6103. (New Year's Day; Martin Luther King, Jr. Birthday, the third Monday in January; Washington's Birthday, the third Monday in February; Memorial Day, the last Monday in May: Independence Day, July 4; Labor Day, the first Monday in September; Columbus Day, the second Monday in October; Veteran's Day, November 11; Thanksgiving Day, the fourth Thursday in November; Christmas Day, December 25.) On those days the ignition, discharge or use of consumer fireworks between the hours of 12 midnight and 8 A.M. or between the hours of 1 A.M. and 8 A.M. on New Years' Day is prohibited.
- b) On the Friday and Saturday immediately preceding and immediately following the July 4 holiday; between the hours of 8 P.M. and 12 midnight.
- c) A person shall not ignite, discharge or use consumer fireworks on public property, school property, church property or the property of another person without that organization's or person's express permission.
- d) The possession or use of consumer fireworks at any time by a minor is prohibited."
